Financial Literacy

• Initiative through Title III grant LENS (Learner Engagement, Navigation and Support) to address the personal financial literacy needs of students. All DSC first- time-in-college (FTIC), Associate of Arts (A.A.) degree students are required to enroll in DSC's first year student success course, "Managing Your Success." The success course (SLS1122), taught by faculty in the School of Student Life Skills, is designed to help students develop critical thinking skills, cultivate personal responsibility, and encourage academic achievement. In the beginning of 2019, SLS1122 started including new financial literacy content entitled Managing Your Finances (MY\$). Through pre- and post-tests, reading, discussion, and interactive assignments, students are gaining understanding and skills in personal finances, higher education costs, and consequences of financial decision-making. Through this course DSC is ensuring the financial decisions students make are supported by a foundation of knowledge, critical thinking, and informed decision-making.
